after first duly advertising the time and place made sale of the following Negroes which were sold
by the Order of Nathaniel Wilson as a portion of his slaves, to wit: Robert, sold to
be sold Robert at the Price of Three hundred and fifty dollars, Charlotte two hundred and twenty
Eight dollars Glasgow three hundred and fifty dollars and Mollis at three hundred and thirty
dollars amounting to the whole to be sold to be sold and Eight dollars which annual Order was
applied as the said Order directs given under my hand this 13 day of January 1832.
