

married with Emma Simmons in January 1822. directs the Commission to state that he and his wife the property of the money due for the sale of the land and never intended that his wife's mother who acted as his Guardian intended to charge her with some time thereafter. He contends that the Guardian had no right to use more than the interest on the property of the estate, without the consent and approbation of the Court he further directs the Commission to state that in strict justice his wife ought ^{not} to pay more because he states that when he married the Guardian is blind and has been since 1811 and that his wife Emma states that all the business of the house &c. from that time until her intermarriage and he thinks that instead of her paying more that she was entitled to be paid, he also states that from 1812 to 1822 his negro boy Dick & Kent land was more than sufficient for any bread and clothing provisions that time, and therefore he claims the amount of principal due the property of Edwin Simmons estate with interest from the time he was married on Jan'y 15th 1822. also the sum of about \$8.00 due him in the division of intestate's land
