Mary and R. Warren
Will

In the name of God Amen I Peggy R. Warren of the County of Southampton and State of Virginia being in a feeble state of health but thanks be to Almighty God of a sound disposing mind and in memory do make and declare this writing to be my last Will and Testament revoking all other wills by me heretofore made in the following manner and form that is to say.

Item 1st I give and bequeath unto my daughter Martha Wimburn wife of Elias Wimburn one negro woman named Leticia Adams and her increase one parcel bed and furniture and one fine blanket to her and her heirs forever.

Item 2nd I lend unto my daughter Margaret R. Warren the use of one negro woman Clarissa and her two children Lucy and Ely together with their furniture increase during her natural life and if she should have a lawful heir of her body I then give the said negro to her heirs and their heirs forever if she should die without leaving a lawful heir of her body at the time of her death I give the said Woman Clarissa and her two children Lucy and Ely and their increase to be equally divided amongst the children of my two daughters Martha Wimburn and Pricilla Carter to them and their heirs forever. I also give unto my daughter Margaret R. Warren one bed and furniture for choice to her and her heirs forever.

Item 3rd I give and bequeath unto my daughter Pricilla Carter one negro girl named Mincy and her increase which she has in her possession one bed and furniture (her choice) to her and her heirs forever.

Item 4th I leave all the rest of my Estate that is not before mentioned in the bequests to be sold on a Credit of six months by my Executors and the proceeds of the sale to be equally divided between my three daughters Martha Wimburn Margaret R. Warren and Pricilla Carter to them and their heirs forever.

Item 5th and lastly I hereby nominate and appoint my Son Robert Warren and my friend John Darden as Executors to this my last Will and Testament hereby revoking all other wills heretofore by me made. In Testimony whereof I have hereunto set my hand and affixed my Seal this 31st day of October 1835.

in the presence of witnesses present at the signing and signing the same

William Harrison This last Will and Testament of Margaret R. Warren deceased was
Elihu D. Warrum proved by the Oaths of William D. Simmons William Harrison and Elisha
Warren the Witnesses thereto and Ordered to be recorded. And on the Motion of Robert Tar-
ron one of the Executors thereto named (John Darden the other Executor thereto named being dead)
who made oath and together with James Maget and Harrison Parker his Securities entered
into and acknowledged as Bond in the penalty of Three thousand Dollars conditioned
as the Law directs. Certificate is granted the said Robert Warren for obtaining a
probate of the said Will in due form.
