The Commisfuns in reporting upon this Acct Current in a former account which is of record in the States Office charged the sum of \$1766.64, as the Amount due the Decr. 19<sup>th</sup> 1828 when the sum actually due on that day was \$2990.11 there was the sale of some land included in this account, which was sold under the order of the Tutor; One third of which sale was due on the same day that a portion of Charles estate became due, which was on the same 19<sup>th</sup> Decr 1828. the 2<sup>nd</sup> installment became due on the 19<sup>th</sup> Decr 1829 and the 3<sup>rd</sup> & last in the 17<sup>th</sup> Decr 1830. This Account is made up charging these Accounts when they became due No other attention has been made in the account.
