

At a Court held for the County of Southampton the 19th day of December 1836

Mayhew the Executor named in said Will, by his certificate to the Court, refuses to take upon himself the burden of the execution thereof; and on the motion of Mary Gray who makes oath and together with Robert Murray and Jesse Banks for her executor, entered into and acknowledged a bond in the penalty of Twenty thousand dollars, conditioned as the Law directs, Certificate is granted her for obtaining letters of administration on the Estate of said George G. Gray decd. with his said Will annexed in due form.

In Witness whereof I have set my hand and affixed my seal this day and date above written.
