 property above disposed of unto Henry Simmons youngest son of John Simmons. I further desire that
 my daughter Edith A. M. R. Simmons should be sent to school until she has acquired a liberal education.
 I also constitute and appoint N. M. Sobrell Executor of this my last Will & Testament, hereby making all
 former Wills & Testaments. In Witness whereof I have hereunto affixed my hand & set my seal this 23rd day
 of February in the year 1836

This last Will and Testament of Nancy A. Simmons was proved by the oath of Augustus J. Simmons,
 a Witness thereto, and confirmed. And at a Court held for the County aforesaid the 19th day of December
 1836 the same was fully proved by the oath of Fredrick Jordan a Witness thereto and ordered to be
 recorded. And on the motion on Nicholas M. Sobrell the only executor therein named who made oath, and
 together with William J. Sobrell and Zebulon L. Simmons his securities entered into and subscribed a
 bond in the penalty of two thousand dollars conditioned as the law directs and affirms is granted him for
 obtaining a probate of the said Will in due form.
