

my Executors, at four annual (equal) instalments; also my negro girl Sarah, (born in her possession) and her future increase, if any.

7th - I give and bequeath to Lucy Myrick and her Heirs, the sum of two thousand five hundred dollars, to be paid by my Executors at four annual equal instalments.

8th - I give and bequeath to John D. Myrick during the term of his natural life, my quantity of Timber on my Sandford & Mahone plantation, and on my Spring Woods plantation adjoining Alexander Myrick and others, that he may think proper to use in building or repairing houses, and the mill.

9th - I give and bequeath to Doctor Thomas N. Myrick and his Heirs forever my plantation lying in Ruffus County, State of North Carolina, which I purchased of Richard G. Sandford and Col^l F. J. Mahone, reserving part of the Timber thereon to John D. Myrick as above mentioned. I also give and bequeath to said Doctor Thomas N. Myrick and his Heirs forever the following named Negroes, now on said plantation, and their future and future increase of the females, to wit: Ned, Addison, Ellick (Beal), Clara, Cherry, Lydia, Aggy, Griffin, Zilpha, Dinella, Lucinda, Ellick (Boon) Leonard, Abner, Nancy, Maria, Digger, George and Davis (Beal). I also give and bequeath to him and his Heirs forever, all the stock of all kinds and farming utensils on said plantation. I also give and bequeath to him and his Heirs forever my plantation adjoining the lands of Alexander Myrick and others called the Spring Woods plantation, reserving part of the Timber thereon to John D. Myrick, as above mentioned.

10th - I leave to Walter Myrick my Norfolk Borough Lease due in the year 1857, for the purpose of paying off my half of the Bond for the rent of Fishery, in which we were jointly concerned, and the balance of said Receipt; if any I give and bequeath to him and his Heirs forever. I also give and bequeath to him all the claims of every description which I hold against him, provided he shall not claim nor receive from my Estate any debt or debts owing to him by me.

11th - All the balance of my Estate, both real and personal, of every description, not otherwise above disposed of, I give and bequeath to John D. Myrick and his Heirs forever.

12th and lastly - I hereby nominate and appoint Doctor Thomas N. Myrick and John D. Myrick, Executors of this my last will and Testament hereby revoking and annulling all other or former Wills or Testaments heretofore made. In witness whereof, I have hereunto set my hand and affixed my seal, this 22nd day of September, in the year of our Lord, Eighteen hundred and forty nine.
