 his securities entered into and acknowledged ~~and paid~~ the penalty of Forty thousand
 dollars Conditioned as the law directs Certificate is granted him for obtaining a
 probat of the said Will in due form.

In the name of God Amen. I Willie Francis of the County of Southampton and State
 of Virginia being of perfect Mind and disposing memory do declare and publish this my last
 Will and Testament in manner and form following (to wit)

Item 1st I leave and bequeath to my three Grand Children George Thomas David Willie and George
 W. Allright the following negroes to wit; Austin, Dick, Maria, Eliza Agnes and Edward together with
 their future increase with a provision hereafter mentioned. Item 2nd I leave and bequeath to
 my three Grand Children before mentioned the sum of one hundred dollars each to be paid out
 of my estate by my executors to them respectively when they may arrive at lawful ages or to
 their respective guardians legally appointed by the Court of the County when the distribution of my
 estate shall take place, both Items to be subject to the following provisions to wit,

Item 3rd In case of the death of one or two of my Grandchildren before mentioned under the age of twenty
 one years it is my wish and desire that the negroes and money before named shall descend to the sur-
 viving or survivors of the three Children above mentioned thus is the provision above alluded to.

Item 4th I give and bequeath to Henry T. Allright all the lands which I hold against him to him
 and his heirs forever. Item 5th I leave and bequeath to my daughter Polly having the following

negroes by names, Solomon, Violet, Maria, now a small girl, Maria, Andrew, Mary, Polly,
 Virginia and forward to her and her heirs forever with their increase. Item 6th I leave and
 bequeath to Howell Harris my son in Law all the lands which I hold against him to him
 and his heirs forever. Item 7th I leave and bequeath to my daughter Elizabeth Thomas
 the following negroes by names, Jacob, Jimmy, Black Hannah and Titus to her and her heirs
 forever also their increase. Item 8th I leave and bequeath to my son in Law Nathan and Thomas all
 the lands and things which I hold against him, to him and his heirs forever.
