

Item 9<sup>th</sup> I leave and bequeath to my daughter Nancy Jones the tract of land which I purchased  
W. Francis Subin didator Trustee to deed of Trust executed by Howell Rose containing four hundred  
Wills and Twenty nine acres and also the following negroes (by name) Little Rose Emma Henry  
and Phil with their future increase to her and her heirs forever.

Item 10<sup>th</sup> I leave and bequeath to my Son in Law Nathl Jones all the lands which  
I hold against him to him and his heirs forever.

Item 11<sup>th</sup> I leave and bequeath to my daughter Patsy Murdock the lands commonly called  
Westbrook tract and the Reed tract; References may be had to the deeds to ascertain  
the number of acres and the boundaries, also the following negroes (by name) Bird Sam  
Arthur, Jemot, Caroline Eliza, Anger, and Rosetta with their future increase to her  
and her heirs forever.

Item 12<sup>th</sup> I leave and bequeath to my daughter Patsy Murdock the  
sum of five hundred dollars to be paid by my Executors out of my estate for the purpose  
of building a house to her and her heirs forever.

Item 13<sup>th</sup> I leave and bequeath to my daughter Dolly Frances the plantation on which I now live containing three hundred  
and thirty three acres more or less also the following negroes (by name) Old Rose Roger  
Dred Annay Yellow Hannah Avery Hester, Charlotte Lewis and Fanny with their  
future increase to her and her heirs forever.

Item 14<sup>th</sup> I leave and bequeath to my  
Daughter Dolly Frances all my household and kitchen furniture of every description  
all of my farming Utensils including Carbs wheels riding Carriages &c. on stable  
stock of horses cattle sheep and hogs crop of every description which may be growing  
on my lands at the time of my death together with all I may have bought since  
not my wish to have a sale this Item is intended to embrace every article of personal  
property that may be at that time on my plantations not otherwise disposed of or may  
be hereafter disposed of to her and her heirs forever.

Item 15<sup>th</sup> It is my will and desire  
that my Executors should collect all the bonds and accounts due me and from the proceeds  
together with all monies found in the House pay the specific legacies before mentioned.

Item 16<sup>th</sup> I leave and bequeath all the surplus of money remaining after paying the legacies  
before mentioned funeral expences contingencies and just debts if any and should there be  
any other property not disposed of to be equally divided between my five Daughters.

Dolly Elizabeth Nancy and Pella Item 17<sup>th</sup> And Lastly I hereby nominate and  
appoint my friends Joseph J. Beland Esq. together with my three Sons in Law David  
Harris, Nathan N. Thomas and Nathaniel Jones Executors to this my last will and

Testament - And I hereby revoke all other will or wills heretofore made by me whether  
verbal or written: In Testimony whereof I have hereunto set my hand and

affixed my seal this 7<sup>th</sup> day of September in the year of our Lord 1837
