Whereas Rowell Branch died in the year 1833 made his last Will and Testament, in which he left a good portion of his property to be sold by Henry Griffin his Executor for the purpose of paying his debts But loaned the largest portion of his property to his wife Martha Branch for and during her life and after her death to be sold and divided between his six youngest children, and the said Executor having returned to Court a true and perfect Inventory of his estate in 1834 and the said Martha Branch having lately died and the said Executor being about to sell the property loaned to his wife and not knowing that all the property is still on the plantation, the said Executor has been advised to take another Inventory and appraisement, by Martha Branch widow of the said Rowell Branch, at the time of her death which is as follows:- Taken this 5th day of January 1844 By Thomas Lane James Clayton and Patrick Dols for Henry Griffin Executor
