to wit:

Negroes that is say Peter Harrison Edmund Ned Alice Julia Mariah and all their future  
increase and at her death I give all the above named Negroes and their future increase to the  
children she now has or may have should they live to Lawful age or leave Lawfull issue  
and should all the Children of the s<sup>d</sup> Elizabeth M. Everett die leaving no Lawfull  
issue then & in that case I give all the above named Negroes & their future increase to  
the Children of my Daughter Sally M. Everett to them and their heirs forever.

Item 2<sup>d</sup> I Give to my son James Barnes three Dollars:

Item 3<sup>d</sup> I give to my son Jacob Barnes three Dollars:

Item 4<sup>d</sup> I Give to Daughter Sally M. Everett three Dollars.

Item 5<sup>d</sup> I Give to my Daughter Elizabeth M. Everett all my Bonds Money and accounts

Item 6<sup>d</sup> I do hereby Nominate and appoint my son Jacob Barnes Executor to this my  
last will and testament in Testimony whereof I have hereunto set my hand & seal  
this 24 day of Dec 1843
