 of Wm A Jones Sampson B. Rice & Simon J. Willbanks his
 witnesses sworn and ordered to be Recorded and Elizabeth
 Glend therein named refusing to take upon herself the execution of said Will
 over the Motion of Joseph H Prince one of the Executors therein named who made oath
 and together with Joseph Prince Jos S. Princes David Prince & Thomas B. Williams his
 Securities entered into and acknowledged a bond in the penalty of one hundred and sixty
 Thousand Dollars conditioned as the law directs Certificate is granted him for delivery
 probat of said Will in due form liberty is reserved for the other Executor to be named in
 said probat when he thinks fit
