In the Name of God Amen I Zachariah Turner of the County of Southampton and State of Virginia being weak in body but of sound Mind and Memory thanks be to almighty God for the same do now think proper to make this paper writing as and for my Last will and Testament in Manner and form following, (Vizt)

Item I have to my beloved wife Nancy Turner all of my Estate both real and personal of every kind whatsoever (except due by God) for and during her single life upon the Condition that my children all remain with her and live on the same but should my wife ever marry I wish her to have one third part of my Estate as above named for and during her Natural life and No More

Item I Give and bequeath to my son Morris Turner one half to him and his heirs forever

Item after the death or Marriage of my wife I Give and bequeath all the property I have bequeathed to her to my four children Namely Morris Sally Peggy and Peter Turner to be equally divided between them to them and their heirs forever

Lastly I do hereby Nominate constitute and appoint my son Morris Turner and my friend John Harris as my sole and sole Executors to this my Last will and Testament reaching all the wills heretofore by me made In Testimony whereof I have hereunto set my hand and seal this 28th day of February 1841

At a Court held for the County of Southampton on the 21st day of October 1841
This Last Will and Testament of Zachariah Turner deceased was proved by the oath of Joseph H Johnson & John Johnson two of the subscribing witnesses thereto and sworn to be Morris and Morris Turner & John Harris the Executors therein named refusing to take upon themselves the burden of this bequest thereof on the Motion of John D Johnson who made oath and testified with William Harris & Matthew Harris his brother's natural sons and acknowledged as such in the presence of fifteen hundred dollars Conditional as the law directs Certificate is granted here for necessary letters of administration on the Estate of the said Zachariah Turner with his seal annexed in due form

Item 3rd I Give to Margaret Ann Vick the daughter of Mills Vick's Mother her wife the sum of one hundred dollars to her & her heirs forever

Item 4th I Give to Vienna Jones the wife of William Jones the balance of money that may be left after the three legacies aforesaid given that includes what money I have
