 above and in that case I Give and bequeath unto him One Negro named
 Wadswort to him and his heirs forever

Item 6th On condition that William B Westbrook shall be satisfied
 with stand to and abide by a settlement which has been made between
 his Guardian and myself relative to his portions of his Fathers estate
 above and in that case I Give and bequeath unto him One Negro boy
 Sandy to him and his heirs forever

Item 7th I Give and bequeath unto my friends Joseph M S Rogers
 One horse first choice of my stock to him and his heirs forever

Item 8th On Condition that the above named persons to wit Tho^s H
 Westbrook James B Westbrook and William B Westbrook refuse to stand
 to and abide by the statements above referred to in their respective Items
 above and in that case my will and desire is that the Negroes conditionally
 withheld for them to wit Georgeanna Wadswort and Sandy be equally divided
 between my two Nephews Henry W Sney and Benjamin S Sledge to them
 and their heirs forever

Item 9th It is my Will and desire that all the property of which I
 may die seized and possessed not herein given away shall be sold by
 my Exors and after paying my just debts the remainder if any I Give and
 bequeath as before to my said Nephew Benjamin S Sledge to him and his
 heirs forever

Item 10th I Give and bequeath unto my niece Elizabeth Sney the plantation
 wharof my Brother George Sney has since known by the name of the old
 place to her and her heirs forever

Item 11th I Give and bequeath unto my niece Lucy Sney the
 following Negroes. Namely Isaac Child Rogers and Amos to her and her
 heirs forever It is also my will and desire that my two nieces Elizabeth and
 Lucy Sney shall take care of and support their Father during his life
 and in case either of my said nieces should die without lawful issue
 my Will and desire is that portion willed to them or each of them be
 equally divided between my two nieces Elizabeth Wadswort and Rebecca
 Sney to them and their heirs forever

Item 12th I hereby nominate and appoint my worthy friends Henry
 W Sney and Joseph M S Rogers Exors. to this my Last Will and
 Testament with a request that the most Worshipful Court of
 my County shall not require any securities of them the said
