 as follows, to-wit:  
 Item 1<sup>st</sup>. It is my will and desire after my death that all my estate both real and personal be sold  
 and out of the moneys from such sale all my just debts be paid.  
 Item 2<sup>d</sup>. After paying my debts, I leave the balance of my estate to my wife Mary E.  
 Wren, during her life or widowhood and at her death or marriage I then give said balance  
 to her being child or children to her or them forever.  
 Item 3<sup>d</sup>. I hereby nominate and appoint my friend Chas. B. Mount my sole Executor  
 to this my last will and Testament, and also request said friend to become guardian to my  
 child or children.

 of June 1851.
