

Item 2^d. I give and bequeath unto my son Josephus Turner, all my lands, to him and his heirs forever.

Item 3^d. I give and bequeath unto my son William Turner, ten dollars to him and his heirs forever.

Item 4th. I give and bequeath unto my daughter Susan Howell, ten dollars to her and her heirs forever.

Item 5th. I give and bequeath unto my daughter Martha Butler, ten dollars to her and her heirs forever.

Item 6th. My will and desire is that the remainder of my estate be equally divided between my two sons (Trust) Josephus Turner, & William Turner, to them & their heirs forever.

Lastly, I do hereby nominate, constitute & appoint my son Josephus Turner, my whole and sole executor to this my last will and testament, revoking all the wills heretofore by me made. In Testimony whereof, I have hereunto set my hand, and affixed my seal this 20th day of July 1851.

At a Court held for the County of Southampton, the 20th day of October 1851.

And on the motion of Josephus Turner the executor therein named, who made oath and together with Eli Soyner and Jeremiah Soyner his securities, entered into and acknowledged abroad in the penalty of one hundred and fifty dollars, conditioned as the law directs. Certificate is granted him for obtaining a probat of the said will in due form.
