Jones to him and his heirs forever.

Second. I give and bequeath unto my boy John son of my old negro woman Sally who now lives in Ohio fifty dollars to him and his heirs forever.

First. I give and bequeath unto James R. Joyner and George F. James my wife Austin, as my desire that they should hire him out for the benefit of Mrs. Austin or else let him live with her and cultivate her land.

Fourth. I give and bequeath unto George S. James and the said John son of my
