

Slut. I give to my daughter Indiana B. Briggs in addition to the negroes I formally gave her the following negroes and their future increase, To wit: Sally, Lewis, Daniel and Jack all to her and her heirs forever.

Slut. I give to my daughter Mary B. E. Shanderson the following negroes and their future increase, to wit: Blacksmith Best, Emma, Andrew, John, Martha, Harriet, Saddy, and Ann, one bed and furniture, which she lately made all to her and her heirs forever.

Slut. I give to my grand daughter Virginia Trague one negro girl named Betty all to her and her heirs forever.

Slut. I give unto my great grand daughter Magnus Trague one negro girl named Caroline to her and her heirs forever.

Slut. I wish Henry whom I purchased at Sufray Courtthouse in whom the Perkins have an interest to be turned to those who have the legal right to receive him immediately after my death.

Slut. It is my will and desire that the following negroes to wit: Cissy, Amistad, Jim, Washington, Little Ben, and Ned be hired out annually during the life of my wife and the proceeds of the hire be divided at the end of each year as follows, divide the amt. in seven equal parts allot one to each of my children and divide seventh equally between my two grand children Virginia Trague and Thomas S. Morgan, and at the death of my wife I wish my executor to make an equal division of the above named negroes together with those loaned my wife among my six children or their legal heirs, Dilia excepted, I wish her to go to either she may think proper to select they accounting for her valuation in the division. This division I wish made as follows. All my sons and sons in law to assist in parceling them out and draw for lots as numbered from one to six, that all receive and account to my executor for the same on this proviso, that no claim is to be brought against my estate by any legatee herein named except alone, which Henry B. Briggs holds, in that what they forfeit all interest in my estate of every description, but in strict compliance with the above I give it to them and their heirs forever.

Slut. All the rest and residue of my estate of every description including my my two plantations Morland and Carleton Land sold whenever my Executor shall think proper to do so. And at the death of my wife I wish the property loaned her sold and divided in the same manner as the rest of the property is divided to be divided with the exception of the land and negroes, the negroes I expect can be divided without making sale of them, the land will go to Thomas S. Morgan. Also I give him one negro boy, named David.

Slut. I appoint my son William S. Shinderson Executor of this my last will and testament. I wish no appraisement of my estate to be made and request the Court not to exact security of my Executor for his Executorial transactions I have full confidence in him. I have tried to be very particular in all and every part of this will, but as I may not be fully understood by all interested in my estate I wish it distinctly understood if any difference of opinion should at any time exist between them, that the matter in controversy be submitted to three disinterested persons of respectability appointed by parties concerned whose decision shall be final and furthermore I wish it particularly understood that if either of my children or those in any manner interested in my estate in any way whatsoever should have the temerity to enter into a lawsuit of any description he or she is violating my earnest wish shall forfeit his or her interest in all and every part of my estate whatever.
