To the County Court of Southampton County:

Your Commissioner reports to the Court that on the 15th day of April 1853 at the request of Samuel Kells the administrator of the estate of Joseph Pope dec^d he appointed the 21st day of June last at his office in the Town of Jerusalem for receiving proof of debts & demands against the said decedent or his estate, and posted a notice of such time and place to the creditors of the said estate and all others concerned, at the front door of the Courthouse of said County on the first day of two successive times of the County Court of said County, to-wit: last May and June terms last. That the several creditors of the said estate whose names are mentioned in the foregoing account appeared before the Commissioner at his said Office upon the day specified in the notice and exhibited and proved to the satisfaction of your Commissioner their several debts or demands against the said decedent or his estate, as set forth in the said account upon which the Commissioner has computed the interest up to July 1st 1853, and finds the aggregate amount of said debts & demands inclusive of interest to be \$129.53 and that they belong to one class.
