In obedience to an order of the General Court of Southampton County made at
August term last, recommending the account of William D. Maxwell (Admin. of John P. P.
Bond dec'd.) the Commissioner begs leave to make the following report. The Commissioner
was not aware at the time that he made his last report that the said William D.
Maxwell had ever returned any account of his transactions as Admin. of John P. P.
Bond dec'd., and he therefore proceeded to settle his account as if none had been then
returned. He now finds that he had returned an account within the time pre-
scribed by law, and that the balance due by said report on the 1st day of
October 1854, was \$307.31 with interest on \$237.11 from date. The
Commissioner is of opinion that he has no authority to reopen the said
account for the purpose correcting errors, but that a bill to discharge and
relieve said account must be brought. He therefore reports the above balance
as due from the said Admin. to the estate of his said intestate.
