To the County Court of Southampton County.
Your Commissioner reports to the Court, that on the first day of September last, at the request of John S. Beach the Administrator of the estate of William D. Manis deceased, he appointed October 18th 1855. at his office in the Town of Jerusalem for receiving proof of debts & demands against the said decedent or his estate and posted a notice of such time & place to the creditors of the said estate and all others concerned at the final day of the Commission of said, on the first day of two successive terms of the County Court of said County to wit: at September and October last. That the several creditors of the said estate who are named or mentioned in the foregoing account appeared before the Commissioner at his said Office, upon the day specified in the notice and exhibited and sworn to the satisfaction of your Commissioner, their several debts & demands against the said decedent or his estate as set forth in the said account, upon which the Commissioner has computed the interest up to the 15th day of October 1855. and on that date, finds the aggregate amount of proof debts & demands
