To the County Court of Southampton County.

Your Commissioner reports to the Court, that on the 1st day of August last, at the request of Robert L. Sind adm^r of the estate of Francis Wells dec^d, he appeared the 17th day of September last, at his office at the Court House of said County, for receiving proof of debts & demands against the said decedent or his estate, and posted a notice of such time and place to the creditors of the said estate and all others concerned, at the front door of the Court House of said County on the 1st day of two successive terms of the County Court of said County, to wit: at August & September terms last.
