Jerusalem October 31<sup>st</sup>, 1857

To the County Court of Southampton County.

Your Commissioner reports to the Court, that, on the 9<sup>th</sup> day of July last at the request of James H. Sevier the administrator of the estate of Elizabeth D. Polkham deceased he appointed the 26<sup>th</sup> day of August 1857, this Office, at the Court house of said County, for receiving proof of Debts or Demands against the said Decedent in his estate and posted a notice of such time and place to the creditors of the said estate and all others concerned, at the front door of the Court house of said County, Court on the first day of June Successive terms of the County Court of said County, July and August Term last. And all of the creditors not appearing within said 26<sup>th</sup> day of August 1857, your Commissioner adjourned the same till the 26<sup>th</sup> day of September 1857. And all the creditors still not appearing to prove their Debts in the instance of the administration your Commissioner again adjourned the same till the 19<sup>th</sup> day of October 1857. That the several of the said estate whose names are mentioned in the foregoing account appeared before the Commissioner at his said Office upon the several days specified in the notice and days to which the account was adjourned and exhibited and passed to the satisfaction of your Commissioner their several Debts or demands against the said Decedent in her estate as set forth in the foregoing account upon which the Commissioner has computed the interest up to the 1<sup>st</sup> day of October 1857 and that day for the aggregated amount of said debts or demands inclusive of interest to \$638.33. All of said Debts or Demands being of the same or H<sup>o</sup> Class or classified into Class of Virginia. Given under my hand, as Commissioner of the said Court, the day and year first aforesaid.
