To the County Court of Southampton County.

Your Commissaries report to Court that Thos. A. Seegins the Administrator of Mallory S. Seaman has exhibited before him a statement of all moneys received by the said Administrator or with which he had become chargeable or had disbursed during the period combined in the foregoing account together with the vouchers in support of the disbursements that he finds a balance of \$2280.91 to be due by the said Administrator to the said estate with the 30<sup>th</sup> day of November 1858 with interest thereon from that day. That the said account is supported by satisfactory vouchers, and that the said Administrator has given such bond as the law requires the penalty whereof and the securities thereto are sufficient in the opinion of the Commissaries. That the said Administrator was embraced in the list of fiduciaries posted up at the front door of the Court house of Southampton County, on the first day of June Court last, and since that day (five days having elapsed since the same was thus posted up) the foregoing account is given under my hand as Commissaries aforesaid, the day and year first aforesaid.
