To the County Court of Southampton County.

Your Commissioner reports to Court that George W. Vick the administrator of Wilkison J. Davis has exhibited before him a statement of all moneys received by the said Administrator or which he had become chargeable with and disbursed, during the periods embraced in the foregoing account together with the vouchers in support of the disbursements. That he finds a balance of \$48.17 due by the said Adm. to the said estate on the 1<sup>st</sup> day of March 1860, with interest on \$45.06 from that day. That the said account is supported by satisfactory vouchers, and that the said administrator has given such bond as the law requires the penalty whereof and the securities thereto are sufficient in the opinion of the Commissioner.
