

In the name of God, Amen: I Robert M Wrenn of the County of Southampton and State of Virginia do make and ordain this my last Will and Testament in the manner and form following.

- 1st I desire that all my just debts and funeral expenses be paid.
- 2^d I desire that all the property I may own at the time of my death may be sold and distributed as I shall hereinafter direct.
- 3^d I desire that my negro man Williams may be sold to Thomas J Wrenn if he wants him and said negro wishes to live with him, and that the said Thomas J Wrenn shall have ample time to pay for him.
- 4th After the payment of all my just debts I desire the distribution of my estate as follows. To Anna E Alice A. & Eugenia P Pennington the sum of fifty dollars each, to them and their heirs forever.
- 5th I desire that the remainder of my estate be equally divided between brothers Andrew J Wrenn & Edward M Wrenn and my sister Martha A. E Thweatt to them and their heirs forever.

Lastly I hereby nominate and appoint James St Mangum Executor of this my last will testament. In Witness whereof I have hereunto set my hand and seal this 23^d day of May 1864.

At a Court held for the County of Southampton on the 17th day of November 1862. This last Will and testament of Robert M Wrenn de^d was this day proved by the oaths of L.R. Edwards and R. J. Darden the subscribing witnesses thereto and thereupon ordered to be recorded and on the motion of James St Mangum the executor therein named who made oath and together with Thomas J Wrenn and Fortunatus Dunn his securities (who justified on oath as to their sufficiency) entered unto and acknowledged a bond in this penalty of five thousand dollars conditioned according to law, certificate is granted him for obtaining a probate of the said will in due form.

First, after all my lawful debts are paid and discharged the residue of my estate, real and personal I give and bequeath and dispose of as follows to wit. To Sally Williams the daughter of Goodman Williams I give all my estate after paying all necessary expence burial and welting in the grave yard. if she dies without a lawful heir then William St Johnson the son of Jonathan Brith is to have my estate. Likewise I make, constitute and appoint my friend Geo. W Spivy my Executor without security and also to hold the proceeds of my estate untill the said Sally Williams becomes twenty one years of age without interest. of this my last Will and testament hereby revoking all former wills by me made - In Witness whereof I have hereunto subscribed my name and affix my seal this
