

pray the rent for the same, or if she prefer, I direct my Executor to buy a small farm for her wherever she may select, the said farm to be loaned her during her life or widowhood, and at her death or intermarriage to go to my children and their heirs forever.

Art. 5. I give unto my wife five barrels corn, three hundred pounds bacon or a proportionate quantity of pork.

At her death I give the said personal estate so loaned, to my children, share
