A writing bearing date the 5<sup>th</sup> day of September 1864 purporting to be the last will  
and testament of James M. Drewry dec<sup>d</sup> was produced in Court in order to be proved, and  
the subscribing witnesses thereto being in the Confederate service as soldiers. John M. Peters  
and David M. Drewry being sworn and examined and from their evidence it is the opinion  
of the Court that the said writing and the signature of Jas. M. Drewry thereto is wholly in the  
hand writing of the said Jas. M. Drewry. Whereupon it is ordered that the said writing be  
recorded as and for the last Will and testament of the said James M. Drewry dec<sup>d</sup>. And on  
the motion of William M. Drewry, the executor therein named, who made oath and entered  
into and acknowledged a bond (the will directing no security to be taken) in the penalty of fifty  
thousand dollars conditioned as the law directs, Certificate is granted him for obtaining a probate  
of the said will in due form.
