To the County Court of Southampton County.
Your Commissioner reports to the Court, that George St. Jordan, administrator of Samuel St. Jordan
exhibited before him a Statement of all Moneys received by the said administrator or with
which he has become chargeable or had disbursed during the periods embraced in the
foregoing account, together with the Vouchers in support of the disbursements. That he finds
a balance of \$2366.69 to be due by the said administrator to the said Estate,
on the 15th day of October 1867, which interest thereon till paid. That the said account
is supported by Satisfactory Vouchers and that the said adm. has given such bond as
the law requires, the penalty thereof and the Securities thereto are sufficient in the opin-
ion of the Commissioner. That the said adm. was embraced in the list of Fiduciaries
posted up at the front door of the Court House of Southampton County on the first day of
April 1867, Court held, and now on this day, (ten days having elapsed since
