State of Virginia, do hereby make and publish this my last Will & Testament
in manner and form following, that is to say.

Item 1st: after my decease, I desire that my Executor herein after named, to
sell all my perishable Estate, on the usual terms, and pay all my just debts
and funeral expenses.

Item 2^d: I give and bequeath to my daughter Martha Whitehead and her
heirs, the sum of one dollar.

Item 3^d: I give and bequeath to my daughter, Margaret J. Wilson, and her
heirs, one fourth part of the balance of my Estate.

Item 4th: I give and bequeath to my daughter Nancy E. Wilson and her heirs
one fourth part of the said balance of my Estate.

Item 5th: I give and bequeath to my three grand children, namely, Henry
J. Antone A. and Benjamin R. Wilson and their heirs, one fourth part
