In the name of God amen I Joshua Dick of the county of Southampton & parish of St Luke being of sound and disposing mind memory & thanks be given to Almighty God for the same & knowing that it is appointed unto all men once to die & being professes of a true real personal estate in possession of the same in manner & form following to wit I give bequeath and devise unto my loving wife Elizabeth the sum of one hundred dollars during her natural life namely £100 & Hannah of the plantation whereon I now live half the stock of horses cattle sheep & hogs that I am now possessed with half the household goods & after the decease of my wife that they and their increase & the stock to be equally divided between my son & daughters & their heirs for ever I give bequeath and devise unto my daughter Ann & her heirs forever Rachell & Tom also one hundred and fifty acres of land joining William Thomas land that he bought of Thomas Belint to her & her heirs for ever

I give bequeath & devise unto my Daughter Beda my negro man Chambl & Judah also forty pounds current money of Virginia when she is married to her & her heirs for ever & so in

I give bequeath & devise unto my son William negro Sarah Jeremy & Bob also after my wife's decease the plantation & all the remainder of my lands to him & his heirs for ever & so in

Lastly my will faceth is that after my wife's decease my whole estate that shall be left after paying of my debts & legacies aforesaid be equally divided between my three children I have also appointed my wife Elizabeth my loving brother Jacob Dick & Arthur Dick Executors of this my last will & testament In witness whereof I do hereunto set my hand & seal this eleventh day of March 1767
