In the name of God I Richard Ivory of Southampton, County being sick and weak of Body but of sound mind and memory therefore calling to mind the uncertainty of life have thought proper to make and make this to be my last will and testament as followeth
 I Give and bequeath unto my son, said Ivory one feather bed and furniture and all the rest of the estate he has had of me
 I Give and bequeath to my son Thomas Ivory five shillings to be raised out of my estate
 I Give to my son Edward Ivory three pounds which I have paid already for him to John Withers
 I Give to my daughter Martha Ivory one feather bed and furniture, three head of cattle and all the other estate of mine now in her possession
