 John the plantation whereon Inoculison liveth with all the edifices
 and improvements on the same containing two hundred & forty
 acs be the same more or less together with one negro girl named
 Peggy and her Offspring to him & his heirs forever.

Item I give and bequeath to my daughter Martha and her heirs forever
 one negro girl named Rachel with her Offspring to her & their heirs
 forever. Item I give the remainder of all my worldly substance
 not yet disposed of be equally divided between my sons Joseph, Giles,
 Matthew, Jordan also my daughter Martha to be equally divided
 between them and their heirs forever. So to have Hannahs Siles
