Eleventhly My Will & desire is that the legacies given my Children as above remain  
in the possession my wife until my said Children severally come to the  
age of twenty one years or intermarry & further. I desire after the death of  
my wife that the negroes lent her & their Increase from this time be equally  
divided amongst all my Children herein named or the survivors of them  
or their heirs. I also desire after the death of wife aforesaid that all my land  
herein mentioned & lent my wife be sold for the best price that can be had  
and the money arising therefrom be equally divided amongst my six  
Sons herein named or the survivors of them or their heirs & after my just  
debts & legacies are paid all the remainder of my estate of every kind not  
before given away. I give unto my loving wife Ann Blunt & her heirs  
And lastly I do hereby constitute & appoint my friends Edwin Gray &  
William Thomas whole and sole executors of this my last will & testament  
revoking all former wills by me made desiring no appraisement of most  
be made in witnesses whereof I have hereunto set my hand & seal this  
26 Day of September 1777
