 memory praised be to god for the same And writings to Dispose of my worldly be-
 nefits or Riches impairs my understanding my understanding or death prevent me
 to make this my last will and testament in manner and form following first
 I humbly recommend my Soul to almighty God that gave it me And wholly
 trusting to his gracious Acceptance thereof and to have full pardon and Remission
 of my Sins thro the merits and mediation of my Blessed Lord and Saviour Jesus
 Christ and my body I commit to the earth to be buried in such manner as my
 Executors hereafter named shall think fit and as for what worldly estate it hath
 pleased god of his goodness to bestow upon me I give and dispose thereof as follows
 my will is that my Son George Clements have the rents and profits of my plantation
 in Prince George County whereon he now lives for and during his natural life but at
 his death I give and devise that plantation together with all my land hereunto
 appertaining to be divided between my five Grand Children the Children of my Son George
 Clements (to wit) Elizabeth Thomas Lucy George & Richard Clements having regard to
 the quality as well as the Quantity I give to them or the Survivors of them
 and their heirs forever at the time of my Son George's decease
 I give and devise to my Son Benjamin Clements the plantation I now live
 together with all my land adjoining there being about Nine hundred & thirty
 Acres I give to him and his heirs forever I also give him four negroes my negro man
 Robin Razel Frank and my Negro Woman Beck to him and his heirs and
 I do also confirm the gift of several Slaves before given him and now in his
 possession to him and his heirs
 I give and bequeath unto my Son Thomas Clements four Negroes my Negro man
 Jacob Lewis Mingo and my Negro Woman Doll to him and his heirs I do also
 confirm the gift of the several Slaves before given him and now in his possession
 to him and his heirs
 I give and bequeath to my Daughter Anna Clements ten Negroes my
 negro man Dick my Negro woman Jane my Negro girl Patt my Negro boy
 Bob my Negro girl Beck my Negro boy Harry my Negro Girl my negro
 Girl Hannah my negro Girl Sallie and my negro Girl Venus to her and her
 heirs I also give her two hundred pounds current money of Virginia I also give
 her one feather bed and furniture my Chest of drawers Six Chairs and two tables
 I give and devise to my grand Son Jose Butts one hundred Acres of Land it being
 the land that I purchased of Charles Gilliam I give it to him and his heirs forever
 I give and bequeath to my Daughter Elizabeth Butts fifty current money
 I give and bequeath unto my Daughter Sarah Butts my negro woman Sal to
 her and her heirs I also give I also give her fifty pounds current money of Virginia
 I give and bequeath unto my nine grandchildren the Children of Peter Butts
 (to wit) Thomas John Benjamin William James Daniel Lucy Mary and Elizabeth
 Butts to each of them twenty five pounds current money
 I give unto my grand daughter Judith Gilliam my Negro boy Ned to her &
 her heirs I also give her one hundred and fifty current money I also give her
 one feather Bed and furniture
 I give and bequeath unto my Grand son Thomas Clements Gilliam
 my Negro Boy Daniel to him and his heirs I also give to him one
