 to hold to my said son Benjamin Deloach and his heir and assigns forever
 Also I give unto my said son Benjamin Deloach these following Negro Slaves
 (viz) Dick Jack Moses Arthur Beck with her Children Roger Tillas Nora Sampson
 Tem Joham & Tom together with the future Increase of the said Slaves to hold
 to my said son Benjamin Deloach & to his heirs assigns forever
 Also all the rest residue & remainder of my estate of what nature or kind soever
 I give and devise & bequeath unto my afore said Son Benjamin Deloach & to his
 heirs forever It is my intention that the Legacy of my said son one hundred
 & twenty pounds herein before given to my Grandson remain in my estate
 to my son Benjamin Deloach provided my said Grandson shall not arrive
