I give and bequeath unto my Daughter Lucy Phillips & her heirs forever my Negro Boy named Peter

I give and bequeath ^{unto my daughter} Mary Tarver Twenty five pounds to be paid my Son Henry on his getting possession of the above named negroes

I give and bequeath unto my Granddaughter Sarah Long ten pounds to be paid by my Son Henry on his getting possession of the above mentioned Negroes

I give and bequeath unto my friend Richard ~~Knorr~~ it being for value Received seven acres of land bounded by his own Charles Holt and John Thops Land to him and his heirs forever

I give unto my three grandsons (Sons of Son Drury namely Etheldred Thomas James Davis forty Shillings to be raised out of my estate

my will and Desire is that all my just Debts and legacies be paid and that my wife Mary have the use of the remainder of my estate of what nature or kind during her natural life and after her ~~Decease~~ to be equally divided between my Son Henry Davis my my Grandson Philip Davis my Daughter Mary Tarver Lucy Phillips Henry Davis and Granddaughter Sarah Long or their heirs forever I do hereby constitute & appoint my Son Henry Davis Executor of this my last will and testament desiring that be no appraisement on my estate for witness whereof I have unto set my hand & Seal this twenty four Day of June 1778
