In the Name of God Amen. I Benjamin Clements of the parish of
 Stollway County of Southampton being in full health & memory do make this my
 Last Will & Testament. After my Funeral expenses & Debts are paid I give
 & Bequeath my Estate in the following manner.

Item, I give to my Son Tho^s Clements my Plantation on the Angell Swamp Con-
 taining six hundred and twelve Acres also the Stock of Hogs Horses cattle & sheep
 & the crop of every kind and plantation & inticible of every kind I give the Above
 mentioned to him & his Heirs for ever. I also give my Son Tho^s & his heirs for
 ever a tract of Land adjoining to the River that I purchased of Pleasant Hook
 containing Four hundred and thirty Acres the corner of the S^d Land may be made
 Apparent by a Deed of Bargain & Sale recorded in the General Court January one thousand
 seven hundred & seventy four. I also give my Son Tho^s & his heirs for ever the following
 Slaves, Jex, Ned, Boco, John, Mithel, Delu, Robin, now highbanded to Samuel Clifton
 Lundy, Tom & Sarah & after the Death of my Wife I give him & his heirs for ever my
 Negro Mankes & girlbook

Item, I give my Son Francis Clements & his heirs for ever the plantation whereon my
 Father lived containing Nine hundred & thirty Acres also my other lands adjoining the
 Plantation on the West side of the Great Pond containing about four hundred & eighty
 Acres also I give him & his heirs for ever the following Slaves to wit George Peter Hall
 Robin Boff Amey Biv, Peares Calis Daughter of Delu Old Beck & Sarah also I give
 him the stock of Horses cattle Hogs & sheep & plantation & inticible to his crop of every
 kind that may be on the plantation & after the Death of my Wife I give him the
 following Slaves Tony and Tal my sword now lent to Tho^s Butler & my Gun
 given me by my Father also I give him stock of cattle Hogs & sheep that may
 be on my Plantation Int^o St. Lukes Parish now mentioned to Samuel Clifton I give
 the Above mentioned to him & his heirs for ever.

Item, I give my Son John Clements after the Death of my wife the Plantation whereon I
 now live together with all my other Land adjoining in the East side of the Great pond this
 being about Nine hundred Acres I give it to him & his heirs for ever I also give my Son
 John the following Slaves, Jacob, Tony in Brunswick John in Brunswick Lewis & John
 Pan in Brunswick Charles & Frank & Lucy in Brunswick I give the above men-
 tioned Slaves to him & his heirs for ever. & after the Death of my wife I give him the follow-
 ing Slaves Jack Bet Calis & Monash to him & his heirs for ever.

Item, I give my Daughter Sarah Clements the following Slaves Moggia Jude Sal & Gander
 to her & her heirs for ever.

Item, I give my Daughter Elizabeth Clements the following Slaves Paines Hannah
 Calis & James to her & her heirs for ever.
