

Also I Give and bequeath to my niece Mary Wadsworth one negro Girl called Judy to her and her heirs and assigns forever.

Also Whereas my friend Shadrach Lewis hath kindly promised to be assisting every Week by coming at least twice in the week to order and direct her negroes in their business and to see that they do their duty as negroes ought to do & also to attend his fatherly care to my children, by taking due care as well of their education as of their Estate, and as the said services and care if faithfully attended and performed will not only be handsome but will interfere with his own business, In consideration whereof I Give the s^d. Shadrach Lewis his use and labour of my negro boy Caesar untill my son Eliza Lankford arrives to the age of Twenty one years or in case of his death untill my son Jesse Lankford attains to the age of Twenty one years as aforesaid at which his service and care is to cease and determine.

Also And whereas James Chapple did of his own free will and accord Give up and sell to me, his right (being one third part) in a pair of millstones formerly my Fathers, for service done for me for the s^d. Chapple, but as I conceive that his part or share in said stones are more than adequate to the service I have done him, I do direct my Executors hereafter named to sell my right (being two thirds) to said Millstones, and if the s^d. two thirds shall sell for more than six hundred pounds I do hereby direct and authorize my s^d. Executors to pay one half, the s^d. surplus to s^d. James Chapple or to his Heirs or assigns.

Also, I Give and bequeath all the remainder of my estate real or personal in possession remainder, or reversion, to be equally divided, between all my (Children viz). Eliza Lankford Jesse Lankford Margaret Lankford Phebe Lankford & Ann Lankford And in case it should please Divine Providence to bless me with other Children or Child it is my will and desire that they be included in this clause of my will and I do hereby include them as fully as the they were now born and mentioned by name to them and to their heirs and assigns or to the survivor or survivors of them or their heirs and assigns for ever.

And whereas a part of my negroes must unavoidably be hired out it is my will and desire and I do hereby direct that they shall have the liberty of choosing their own master with the approbation of my Executors and that they shall not be forced to serve Masters wholly against their living provision they will chose for themselves as aforesaid. And as doubt may arise in some part of my last will & Testament by coming contradictions or confusions, In every case of that nature or where my last will & Testament disagree I desire them to apply to Joseph Munnihott and Dr. J. R. Buffum of the Court of Probates or of the for their judgment thereon I desire their judgment or opinion may be taken and established and I do hereby establish as fully to all intent and purposes as the I had so written provided they be unanimous.

Lastly I do hereby nominate constitute name & appoint my wife Eliza Lankford my friend Shadrach Lewis my brother Jesse Lankford my whole & sole Executors of my last will & Testament hereby disallowing all other wills by me heretofore made & signing and confirming this & no other to be my last
