I give the 3<sup>rd</sup> Plantation to my Sister son Isidor Scott to him of his Heirs for ever. Also gives unto my Brother Holliday Recd provided he returns One hundred & Eighty nine pounds Eighteen Shillings Current Money of Virginia to him of his Heirs forever but in Case my Brother Holliday Recd never Returns I give the 3<sup>rd</sup> money to be Equally Divided between my Three Sisters Joannah & Ruth Mourning Recd of Charlotte Recd to them and their Heirs forever. And I do hereby Comittess of Appoint my Friend Samuel Edmunds late fidele Executor of this my last Will & Testament In Witness whereof I have hereunto set my hand and affixed my Seal this Twelfth Day of April One thousand seven hundred Seventy nine.

In the Name of God Amen I Richard Kirby of the Parish of Willingay County of Southampton being in perfect health of sound of reasoning mind and memory do make & Ordain this for my last will & Testament revoking all former wills by me made in manner of sum following.

First I give & bequeath to my Son Benjamin Kirby two hundred acres of land wherowhere he now lives to him of his Heirs forever. Also I give & bequeath to my Son Benj. Two Shillings & a half Currenty of Virginia to be raised & levied out of my Estate to him his Heirs forever.

Secondly I give & bequeath to my Daughter Susanna Elfron one Negro Girl named Lucy to her & her heirs for ever. Also I give to my Daughter Susannah Elfron Two Shillings & a half Currenty of Virginia to be raised & levied out of my personal Estate to her of her heirs forever.

Thirdly I give & bequeath to my Son Silas Kirby one hundred Acres Land wherowhere he now dwells to him of his Heirs forever. Also I give & bequeath to my Son Silas five Shillings & a half Currenty of Virginia to be raised & levied out of my personal Estate to him of his Heirs forever. Also I give & bequeath to my Son Silas a half my death one Negro boy named Daniel to him of his Heirs forever.

Fourthly I give & bequeath to my Daughter Patti Pond after my Death one Negro girl named Pleasant to her of her heirs for ever. Also I give & bequeath to my Daughter Patti Pond Five Shillings & a half Currenty of Virginia to be raised & levied out of my personal Estate to her of her Heirs for ever.
