is before Excepted during her Natural life And after her death to be divided
between my four Children hereafter mentioned or such of them as shall

Item I Give and bequeath to my son Lucius Westbrooks one third of Land
that formerly belong'd to William Westbrooks to him & his heirs forever

Item I Give and bequeath to my son Joel Westbrooks the other half of my share
of all kind of my Personal Estate at the time that my son Lucius

Item I Give and bequeath to my son Samuel W^m Westbrooks the Land
and Plantations whereon I now live after the death of my wife and one fifth
part of my Personal Estate at the time before mentioned to him & his heirs
forever

Item I Give and bequeath to my daughter Phoebe Westbrooks one fifth
of my Personal Estate at the time that my son Lucius shall arrive to the Age of twenty
one years to the said & to her heirs forever
