

maner to wit, beginning at the upper corner of my land adjoining Absalom or Lewis
Jouner's land and the said Denson's land that Timothy Drake now lives on and to extend
and equal distance along each of the said lines of owners and Jordan Denson so far as
shall comprise and include fifty acres of land and I do hereby direct Absalom Jouner to
run the dividing line which I do establish and confirm to all intents and purposes as
fully as if I had laid out the same myself & conveyed the land and promises to the said

Jordan Denson his heirs & assigns by deed on my life time.

Secondly I leave to my dear and loving wife Sarah Drake the use and profits of all and every
part of my estate real, personal, or mixt whether in possession, remainder or reversion for
and during the term of her natural life.

Thirdly I leave to my daughter Mary Drake after the death of my wife the use and profits
of my plantation and all other lands except the fifty acres which I have already devised
to Jordan Denson his heirs &c. for and during the term of her natural life. I also give
her my Negroe woman Sarah, my Negro man Jim and my Negro boy Bob and one
moiety or equal half part of all my other estate not herein otherwise particularly
reserved off to her and to her heirs and assigns.

Fourthly I give devise and bequeath to my daughter Calie Jouner and to my grandson
Joseph Jouner after the death of my wife my Negroe woman Calie my negroe girls
Dennis & Prillis and one moiety or equal half part of all my personal estate and after
the death of my daughter Mary Drake and my wife the plantation and lands where
on I now live, which I believe will be (after the fifty acres devised already to Jordan
Denson is sold off) One hundred and eighty acres or thereabouts, to them and to
their heirs and assigns for ever. I do desire that my Grandson the aforesaid
Joseph Jouner shall have an education suitable to his station of life out of the
profits of this Legacy.

Fifthly I do hereby nominate, appoint & direct my wife Sarah Drake and my
Son in law Absalom Jouner as executors and executor to this my last will and tes-
tament, and I do revoke and disannul all other or former wills by me heretofore made
hereby establishing and confirming this and no other to be my last will and testa-
ment. In witness whereof I have hereunto set my hand and seal this sixth day of
March in the Year of our Lord Christ One thousand seven hundred eighty and three
Signed sealed, pronounced and declared by the said Thomas Drake to be his last will
and Testament in presence of

At a court held for the county of Southampton, etc
on the 10th day of April 1783. This will was presented in Court
by Absalom Jouner one of the Executors therin named the widow Sarah refusing &
proving by the oaths of Lewis Jouner Jr. & Lewis Jouner Jr. two of the witnesses thereto,
and ordered to be recorded. And on the motion of Absalom Jouner the Executor
therin named who made oath according to law a certificate is granted him for
obtaining a Probate in due form giving security. Whereupon we
