I give and bequeath unto my son John Wilkinson & his heirs for ever all  
 the lands I purchased of Stephen Williamson. I also give unto my said son  
 John Wilkinson & his heirs for ever all the negroes that belong to the said  
 plantation together with all the stock of cattle, horses, hogs, sheep and  
 plantation utensils and also two feather beds and furniture.

Item

I give and bequeath unto my son James Wilkinson and his heirs for  
 ever all the lands I purchased of Henry Dawson, Joshua Dawson,  
 David Dawson, Benj. Tucker, John Tucker & Henry-Crafford Tucker.  
 I also give my son James Wilkinson & his heirs for ever all the Negroes  
 that belongs to the said plantation together with all the stock of cattle,  
 horses, hogs, sheep & plantation utensils & also two feather beds and  
 furniture.

Item

I give and bequeath unto my loving wife Elizabeth during of her life the  
 plantation whereon I now live with all the lands belonging to the same &  
 after the death of my said wife I give the said plantation & the land belong-  
 ing to the same to my son James Wilkinson & his heirs for ever. I also  
 give unto my said wife during of her life her choice of Eight Negroes  
 that is now on the plantation whereon I now live & after her death the  
 said Negroes to be equally divided between my sons John Wilkinson and  
 James Wilkinson & their heirs for ever. I also give unto my wife, Elizabeth  
 & her heirs for ever all my household & kitchen furniture of every kind  
 whatsoever. I also give my said wife all the stock of horses, cattle, hogs,  
 sheep & all the plantation utensils of every kind.

Item

I give and bequeath unto my Daughter Sally Wilkinson & her heirs for  
 ever One negro girl named Amy. I also give unto my said daughter  
 & her heirs for ever five hundred pounds current money of Eng<sup>d</sup> to be  
 paid her out of the money due me.

My will & desire is that all the remaining part of my Estate not already  
 given away together with all debts due me, be equally divided between  
 my sons John & James Wilkinson & their heirs for ever, provided that  
 my said son find for their mother use during her life a sufficient  
 quantity of pork for her house use.

I do hereby constitute & appoint my sons John Wilkinson & James Wil-  
 kinson whole & sole Executors of this my last will & testament. In  
 Witness whereof I have hereunto set my hand & seal this 24<sup>th</sup> day  
 of February 1781.
