Item I give and bequeath to my son Pilgrim Pick the plantation whereon he now lives and bounded by the cyprus swamp and the huckle branch to Counsel Pick's lower corner tree, thence the said Pick's line to William Newdorn's line, thence the said Newdorn's line to the corner, thence a line of marked trees to the said cyprus swamp to him and his heirs for ever.

Item I give and bequeath to my son Joshua Pick a parcel of land known by the name of Pick's place beginning at Pilgrim Pick's line on the cyprus swamp and on the said swamp to a small branch which is Lewis Pick's line to David Newdorn's line & along the said Newdorn's line to William Thomas' line to William Newdorn's line & along a line of marked trees to the beginning to him and his heirs for ever.

Item I give and bequeath to my son Richard Pick a certain parcel of land beginning at a place a corner tree running a line of marked trees to Jacob Pick's line along Jacob Pick's line to a corner, thence along a line of marked trees to the beginning to him and his heirs for ever.

Item I give and bequeath to my son Giles Pick the plantation whereon I now live, & bounded by John Everette's line to Jacob Pick's line & by Jacob Pick's line to a line of marked trees, thence to Counsel Pick's line, thence down the huckle branch to the beginning to him and his heirs for ever.

Item I give and bequeath to my son Silas Pick a parcel of land beginning at a corner on Jacob Pick's line thence along Jacob Pick's line to a line of marked trees along the said line to corner on Matthew Pick's line, thence along the said lines to the beginning to him and his heirs for ever.

Item I leave to my loving wife Anne Pick such a reasonable part of my Estate as she and my two eldest sons shall think sufficient for her support during her widowhood, and after her marriage or decease I decree that it may be divided between my nine childrens Lewis Pick, Pilgrim Pick, Joshua Pick, Richard Pick, Pells Pick, Silas Pick, Mildred Newdorn, Sally Pick, Pelly Pick to them and their heirs for ever.

Item My will is that the remainder of my Estate should be divided thus that whatsoever part of my children is living with me at my decease may have just double the portion those have who are settled or acting for themselves to them and their heirs for ever.

Item I do constitute and appoint my loving sons Lewis Pick and Pilgrim Pick and John Chittly son my whole sole Executors of this my last will & Testament.
