 and his heirs forever
 I lend to my loving wife Sarah Read during her life the
 following tract of Land that is above mentioned and Likewise
 the residue of my whole Estate and after her decease my
 Desire is that the whole of the Estate Except the land
 and Cow and the increase of Lard is here above mentioned
 Should be sold at publick Sale by my executors
