 either of the daughters should die without a lawful Issue my will and desire is that her
 legacy should be equally divided amongst my children then alive. Item I give to my
 young wife Ann Gardner the use of my plantation & Land whereon I now live and all the
 residue of my Estate of what kind or quality whatsoever during her natural life my will and
 desire is that my estate ^{may} be kept together with my wife untill my children severally come of
 age to receive their Legacies as above mentioned and my desire is my Estate may not be
 appraised but only an Inventory returned. I hereby Nominate and appoint my wife
 Ann Gardner Executrix & my Son Henry Gardner Care to this my last will & Testament
 revoking all other wills by me before made Ratifying this & no other to be my last will &
 Testament In Witness whereof I have set my hand & affixed my seal this 4 day of
 February 1793.
