 Claud to her and her heirs forever At the same time I desire that my flock of
 horses cattle hogs sheep Household & Kitchen furniture &c. be sold & the money
 arising therefrom to be equally divided between my daughters Polly Dolly and
 Fanny Claud Francis — Item I give to my daughter Fanny Claud Francis
 all my Lands on the East side of the line above mention'd to her & her heirs forever
 should my daughter Fanny die without lawful Issue I then give her part of the Land
 to my daughter Lucy ~~above~~ above mention'd and in case my daughter Lucy die
 without ^{lawful} Issue I then give her ~~2~~ part of Land to my daughters Dolly Dolly & Fanny
 above mention'd — In case my daughter Polly die before she takes possession of her
 Estate I then give her part of my estate to my daughters Dolly & Fanny and in case
 my daughter Dolly die before she takes possession of her estate I then give her part of
 my estate to my daughter Polly & Fanny and in case both my daughters Polly &
 Dolly die before they possess their estate I then give both those parts of my estate
 to my daughters Fanny & Lucy, above mention'd to them & their heirs forever
 Item, my will and desire is that my bonds and open acct. be applied towards
 the payment of my Just debts including the building & completing my new
 house now on hand likewise my crop of Tob. now on hand The balance to be
 equally divided between my four children Polly Dolly Fanny & Lucy to them
 and their heirs forever I do appoint John Barrow and Henry Barrow Executors of this
 my last will & Testament In Witne^s whereof I have hereunto set my hand & affixed
 my Seal this 3 day of April Anno domini 1793.
