

out of it then near a fourth course on a line of mark it lies to a post oak standing in a small pond then near a west course to Harry Pops corner tree where the s^d Popo & the line which ~~is~~ was formerly my fathers line then down my fathers old line to the west corner then on the s^d old line to the Beginning also eight Negroes to wit Phillis Ben, Juse, Nath, Fannis Wash Little Bear & Peper, and other the articles that I have heretofore possessed him with together with the increase of the said Negroes to him & his heirs forever

Item I give and bequeath unto my daughter Charlotte Vick Negroes Hannah & Bob one bed & furniture one bay mare called Nancy a pine painted chest & the increase of the s^d Negroes all to her & she & her heirs forever

Item I leave the labour & use of the remainder of my Negroes to wit Joan, Ned, Lucy, Buff, Jacob & Bill Ben & Mark & Luke and the use of Manor plantation & lands there to belonging & all other of my estate of what nature or kind soever unto my loving wife - Martha Vick during her natural life or widowhood and after her death or marriage I give and bequeath the same & every part thereof that may then remaining at that time & their increase unto my son Newit Vick & his heirs forever

Lastly I do appoint my loving wife - Martha Vick & my two sons W^m Vick & Newit Vick my whole & sole heirs to this my last will & Testament revoking & disannulling all former wills or wills by me hereto made & allowing this & no other to be my last will & Testament In Witness whereof I the s^d William Vick hath hereunto set my hand & affixed my seal this 8th day of August 1764

Land Bird in body at present but of sound & perfect mind & memory thanks be to the Almighty God for the same
While calling to mind the Mortality of my body & knowing it is appointed for all to die do make & ordain
this my last will & Testament viz First of all I desire that all my debts & general charges s^d & discharging

Item I give & bequeave to my son Littleberry Land & his heirs forever one Negro Girl named Bob one negro Girl named Ginna which is now in his possession

Item I give & bequeave to my son Liewallin Land & his heirs forever one Negro Girl named Moby

Item I give & bequeave to my daughter Lucretia Bowers the wife of Britton Bowers & her heirs forever one negro woman named Hannah & one negro Girl named Esther

Item I give and bequeave to my son Lewis Land and his heirs forever the plantation whereon I now live with the whole of my house hold & two Negroes named Pat & Matt & one bay mare

Lastly I nominate & appoint my trusty & well beloved son Littleberry Land my whole & sole executor of this my last will & Testament In Witness whereof I the s^d Bird Land
