Item My desire is after paying my just debts & that all the residue of my Estate not hereto
fore given / receipted by my horse Jack Cole be equally divided Between John & Bowley
Barnes sons of Bailey Barnes to them & their heirs for ever.

Item I give unto William Philips my bay Horse Jack Cole as before receipted to him and
his heirs forever. I do nominate and appoint my friends Edmund Turner & John Dawson his
attorneys in this my last will & testament In witness whereof I have set my hand & affixed my
seal this 6th day of April 1796.

Henry Biantly (Turner one of the executors names, time a Mayor & the other to qualify)

witnesses thereto and ordered to be recorded. And on the motion of the said Edward
who made oath according to law certificate is granted him for obtaining a probate
of in due form giving security whereupon it

ack. In the name of God Amen I James Vick of the county of Southampton being
in perfect mind & memory do make & ordain this my last will & testament in manner
of following first & principally I give and recommend my soul into the hands
of Almighty God & my body to be buried in a Christian like maner at the direction
of my friends hereafter named

Hence to my loving wife Sarah Vick during her Widewhood the land wherein I now
live containing by estimation 315 Acres the land I purchased of Lewis Jones inclining
which said land is adjoining the land of Arthur Derington William Brewster
Bro Williams & Nathl Jones Also Turton Negro Driz late Charles, Tom Jacob, George
Milly, Rose, Peg, Sal, Lindsey, Archer, & Lucy, and a dozen of houses cattle &c
pigs & all my house hold Utchens furniture & Plantation utensils.

Item I give and bequeath to my son Parks N Vick after my wifes decease or marriage
the abovementioned tract of land that is left to my wife to live & her heirs forever.

Item I give & bequeath to my son Richard Vick the tract of land I purchased of Benjⁿ
Andrews adjoining the lands of Samuel Decent & Charles Burge to him & his heirs
forever to my daughter Mary Wren a Negro girl by the name of Charney which
she has now in possession to her & her heirs forever

Item I give & bequeath to my daughter Lydia Wren one Negro boy named Ned who
she has now in possession to her & her heirs forever.

Hence to my daughter Tabitha Vapen one neg girl names Esty during her life
and after her death I give and bequeath the said girl with her increase to her the
Vapen children lawfully begotten to be equally divided to them & their heirs forever
