

Now, I give and bequeath to the child of which my Wife is now pregnant two thirds of my land when ever she marries and the other third at her own death to the child the following names, Ned, Lewis, Abram, Milley, John, Ben, Sterling, Minney, Pleasant, Grace, Sarah, Peg, George & Sam.

It is my desire that all the Stock of Horses not previously mentioned Cattle and Hogs, and the Crop shall be sold and the money arising therefrom to be appropriated to the payment of my just debts. All the remainder of my personal Estate to be equally divided between my Wife and child. If the child dies under age & without lawful issue, it is my desire that all the property previously given to it, shall be equally divided, and I give one half to my brother John Person, and the other half I send my Wife during her natural life, and at her death to descend to John Person, if he is then living or his lawful issue, if not, it is my wish that it shall be equally divided among all the children of Henry Person's present Wife.

I do hereby constitute and appoint John Person and Richard Blunt whole and sole Executors of this my last Will and Testament, Witness my hand and seal this 26th day of August 1798
